2012 Community Benefit Report Executive Summary


This community benefit report describes the programs and services that take place every day at CAMC Teays Valley Hospital to improve the health of our community.

In 2012, CAMC Teays Valley Hospital provided \$8,013,371 in community benefit. Our programs and services go well beyond the traditional health care we think of when we consider hospital care and are delivered both inside and outside the walls of our hospitals. They are driven by our mission, *Striving to provide the best health care to every patient, every day.*

Part of the CAMC Health System, CAMC Teays Valley Hospital, Inc. is a West Virginia nonprofit tax-exempt corporation that owns and operates a 70 bed general acute care hospital in Hurricane, Putnam County, West Virginia. The hospital was purchased from HCA – The Health Care Corporation in 2006 in an effort to preserve hospital and healthcare services in Putnam County. CAMC Teays Valley Hospital provides cardiology, family practice, surgical and endoscopy services, infectious disease, internal medicine, medical intensive care, ophthalmology, nephrology, neurology, orthopedics, pain, pulmonary, radiology, urology and wound care services as well as emergency care, outpatient lab, radiology, physical therapy and ambulatory infusion services.

The residents of Putnam County depend on CAMC Teays Valley Hospital to provide convenient, quality and compassionate care – care delivered regardless of a patient's ability to pay.

We give back to our community because we understand the impact that medical care provided locally in our community as well as charity care, education, corporate contributions and community partnerships have on the lives of the people in our community. In this report, you will read about examples of the programs we provide to the community and how we demonstrate our community commitment.

2012 COMMUNITY BENEFIT SUMMARY

CHARITY CARE AT COST

\$4,114,006

Free or discounted health services provided to persons who meet the organization's criteria for financial assistance and are thereby deemed unable to pay for all or a portion of the services. Charity care is reported in terms of costs, not charges. Charity care does not include (1) bad debt or uncollectible charges that the hospital recorded as revenue but wrote off due to failure to pay by patients, or the cost of providing such care to patients; (2) the difference between the cost of care provided under Medicaid or other means- tested government programs or under Medicare and the revenue derived therefrom; or (3) contractual adjustments with any third-party payors.

GOVERNMENT SPONSORED MEANS-TESTED HEALTH CARE SHORTFALLS

Includes the unpaid costs of public programs for low income persons; the "shortfall' created when a facility receives payments that are less than cost of caring for public program beneficiaries. This payment shortfall is not the same as a contractual allowance, which is the full difference between charges and government payments.

NOTE: Charity Care, Unreimbursed Medicare, Medicaid and Bad Debt – The total cost estimate for this care was determined by applying our Medicare ratio of cost to charges generated for these patient financial classifications.

CAMC Teays Valley Hospital focuses on the health of our patients and our community. Our mission is "Striving to provide the best health care to every patient, every day."


Our vision also shows our commitment to our community:

CAMC Teays Valley Hospital's Core Values are **Quality**, **Service with Compassion**, **Respect**, **Integrity**, **Stewardship and Safety**.

Part of the CAMC Health System, CAMC Teays Valley Hospital, Inc. is a West Virginia nonprofit tax-exempt corporation that owns and operates a 70 bed general acute care hospital in Hurricane, Putnam County, West Virginia. The hospital was purchased from HCA – The Health Care Corp. in 2006 in an effort to preserve hospital and healthcare services in Putnam County.





More than 100 doctors have privileges to practice at the hospital. Along with physicians, nearly 400 nurses and non-clinical staff serve the residents of Putnam County and surrounding areas with emergency services and other specialized care including cardiology, family practice, surgical and endoscopy services, infectious disease, internal medicine, medical intensive care, ophthalmology, nephrology, neurology, orthopedics, pain, pulmonary, radiology, urology and wound care services as well as emergency, outpatient lab and radiology, physical therapy, and ambulatory infusion.

In 2012, CAMC Teays had 2,525 inpatient admissions, 65,450 outpatient visits, and 20,178 visits to our Emergency Departments. CAMC Teays inpatient payer mix is 64% Medicare, 9% Medicaid, 16% Commercial, 6% Self Pay, and 5% Other.

COMMUNITY BENEFIT

Community benefits are programs or activities that provide treatment or promote health and healing as a response to identified community needs and meet at least one of the following community benefit criteria:

- Improves access to health care services.
- Enhances the health of the community.


CAMC Teays Valley Hospital further refines this definition to include community benefits as programs or services that address community health and health-related needs and provide measurable improvement in health access, health status, and the use of health resources.

In total, CAMC Teays provides over \$8,013,371 in overall community benefit to the residents of its primary and secondary service areas.

DEMOGRAPHICS FOR PUTNAM COUNTY

The population of Putnam County was 55,486 in 2010 and increased by 1.7% between 2010 and 2012 to 56,486.

- The White/Caucasian population made up 96.8% of the county's residents.
- The Black/African American population made up 1.0% of the county's residents.
- The Hispanic/Latino population made up .9% of the county's residents.
- Persons age 65 and older made up 14.7% of the county's residents.
- The 65+ age group is the fastest growing age group in Putnam County.

Putnam County Education

During the 2011-2012 school year, Putnam County had 23 public schools with 9,517 students enrolled. The Putnam County Career and Technical Center provides vocational education programs for area students.

The Putnam County 911 telecommunications center responds for requests for emergency assistance. In addition to serving law enforcement, it provides primary dispatch and related services to a number of fire departments.

Putnam County Emergency Medical Services provides emergency ambulance services throughout the county. Duff Emergency in Poca, Medical Transportation Services in Scott Depot, and Trans Med in Barboursville also serve the area.

COMMUNITY HEALTH NEEDS ASSESSMENT

CAMC Teays Valley Hospital conducted its first community health needs assessment process with the United Way of Central West Virginia in 2012 and worked with key leaders in Putnam County (CAMC Teay's Service Area) to establish and prioritize community health needs. Through CAMC Teays' strategic planning process, the community health needs assessment is used to set community health priorities for CAMC Teays Valley Hospital.

The Putnam County needs assessment was coordinated through a Putnam County Advisory Committee coordinated through the United Way of Central West Virginia. Committee Members include:

Objective Data – Secondary County Health Data

A comprehensive database of health related data and statistics is compiled/updated from numerous sources regarding the health of the citizens of Putnam County and incorporated into the document entitled *Health Indicator Data Sheet*. The findings are sorted into 23 categories for ease of reference and provide the following for each indicator: name, data link, Putnam County results, West Virginia results, United States results, comparative trends, notes, West Virginia county rank, United States state rank, and a comparison between the most current and the previous measurements. The *Health Indicator Data Sheet* is available at www.camc.org

Survey Data - The Putnam County Chamber of Commerce completed a survey to identify issues central to improving the overall quality of life for Putnam County. The survey was web-based and an email was sent to people within selected zip codes in the county. 330 Putnam County residents participated in the survey and identified the following health care issues:

As a result, Dr. Rahul Gupta, Health Officer for the Kanawha/Charleston Health Department was consulted on the health needs for Putnam County since a large percentage of Putnam County residents work and seek health care in Kanawha County, including at the Kanawha/Charleston Health Department. Dr. Gupta is an active and vital participant of the Kanawha Coalition for Community Health Improvement and one of his staff members is now serving in a leadership role with the Putnam County Health Department and will be an active participant in this process.


Lance Whaley, Department of Health and Human Resources (DHHR) for Putnam County was also consulted and he shared that his department has individuals seeking assistance for homelessness three to four times per month on average. At the highest, they may have a surge with three a day. The DHHR does an intake and attempts to work with landlords to secure an apartment for the client. The DHHR will pay a security deposit and the first month's

rent. Women and/or families with children get top priority. When asked his priority list of needs for Putnam County, the list included:

- 1. Transportation
- 2. Homeless shelter
- 3. Child shelter like Patchwork
- 4. 24/7 resources for food and clothing
- 5. Substance abuse treatment center

In addition, the 2012 West Virginia Findings of State Public Health System Partner Survey was reviewed for additional data representing the community's interest and their survey respondents identified the following health risks/risky behavior for West Virginia: Obesity (67.93%), Prescription Drug Misuse/Abuse (51.05%), Illicit Drug Use (41.77%), Smoking (38.82%), and Sedentary Lifestyle (29.96%). Three of the five are identified priorities for Putnam County.

To further identify primary and chronic disease needs and other health issues of uninsured, low-income persons, and minority groups, the Advisory Committee reviewed Putnam County beneficiary utilization (number, location and services) of United Way services.

Community Support



CAMC Teays Valley Hospital supports and strengthens the Putnam County community through our annual planning process 1 where we review the needs assessment findings and priorities to develop our community strategy 2 and the community(ies) within Putnam County that are impacted. 3 This strategy is based on issues identified through the needs assessment process and supplemented with findings from review of our internal data. Strategies are identified and plans are funded, implemented, 4 tracked and measured 5. Our Board approves the plan and reviews plan progress annually 6. In addition to addressing community needs and contributing financially, CAMC Teays' President and Associate Administrator serve in key leadership roles for community activities, programs and organizations as well as support the workforce in participating in many community benefit activities.

As part of the strategic planning process, CAMC Teays determines if there are additional areas of support that can be provided to address the identified community assessment issues. The following table lists programs provided by CAMC Teays Valley Hospital that address these community priorities, and are identified and funded as part of operational planning by the CAMC Teays Valley Hospital Board of Trustees.

CAMC HEALTH SYSTEM INFRASTRUCTURE TO ADDRESS COMMUNITY NEED

The CAMC Health System provides quality care for our community residents throughout every stage of life focused on our key strengths of (1) clinical and technical excellence, (2) performance excellence culture and infrastructure and (3) education. We understand the leadership role that health care must play in providing exceptional medical care, charity care, education, corporate contributions and creating community partnerships to address the lives of the real people we care for everyday. What sets us apart is our strong track record of developing partnerships to address health issues. Our creative investment of time and dollars will be even more important to our ongoing work as health care reform results in declining reimbursement and growing need for access to services.

CAMC Health System's history is one of establishing programs and services to meet the needs of the citizens of our community. From our beginning, our focus has been on assessing needs and working to provide the needed services, either solely or in partnership with others. We recognize the responsibility we have serving the central and southern part of West Virginia.

Our patients reside in the Appalachian valleys and mountains in sometimes still difficult to access remote areas. The CAMC Health System, as professionals individually and collectively, believe it is our responsibility to influence the quality of life in ways that transcend the role of a typical hospital. We seek to innovate and implement programs to assure that our people can enjoy all that West Virginia has to offer through the greatest possible health and well being. CAMC Teays Valley Hospital is in existence today because we were asked by the Putnam County community to support its need for continued hospital and emergency services in the county.

SAFETY NET SERVICES

Charleston Area Medical Center provides trauma, NICU and PICU safety net services to central and southern West Virginia.

MEDICAL EDUCATION

Charleston Area Medical Center sponsors thirteen accredited internship, residency and fellowship programs. Programs are accredited through the Accreditation Council for Graduate Medical Education (ACGME) and the American Osteopathic Association (AOA). CAMC sponsors three pharmacy residency programs, accredited by the American Society of Health System Pharmacy (ASHP); a clinical psychology internship, accredited by the American Psychological Association (APA); and a fellowship in oral maxillofacial surgery. CAMC also sponsors a School of Nurse Anesthesia accredited by the Council on Accreditation. CAMC works with education affiliates such as West Virginia University, the West Virginia School of Osteopathic Medicine and Marshall University.

CLINICAL TRAINING SITE

CAMC serves as a clinical training site for approximately 800 students per year through educational affiliations from West Virginia and regional colleges universities. Currently, there are 145 affiliations with health professions programs in 30 disciplines including pharmacy, physical therapy, physician assistant and other health disciplines.



RESEARCH and CLINICAL TRIALS

CAMC Health Education and Research Institute, Inc., a sister company to CAMC Teays Valley Hospital, is actively engaged in clinical trials and has active research protocols in oncology, cardiology/ cardiovascular research, medicine and medicine subspecialties, behavioral health community medicine, pediatrics, nursing research and trauma/pain. The majority of this research is conducted at CAMC hospitals.

ALTHOUGH NOT COUNTED AS CAMC TEAYS VALLEY HOSPITAL COMMUNITY BENEFIT, CAMC HEALTH SYTEM COMPANIES PLAY A SIGNIFICANT ROLE IN COMMUNITY HEALTH IMPROVEMENT:

CAMC Health Education and Research Institute serves as the education and research arm of the CAMC Health System. The Institute promotes the health of the community by:

- Sponsoring health professional training programs training the region's health professionals.
- Providing continuing education to health professionals in the community, region and state.
- Sponsoring management and leadership development programs.
- Sponsoring community health education and prevention education programs for the community.
- Conducting clinical and health services research targeted to improve health and health services delivery of our patients and community.
- Pursuing special program funding and grants to support education and research programs.
- Promoting economic development through its employment of approximately 80 full-time education, research and support staff and through its extramural and externally funded sponsored programs.

Integrated Health Care Providers (IHCPI) is an affiliated company of the CAMC Health System existing to support the mission of CAMC and CAMC Teays Valley Hospital in *striving to provide the best healthcare to every patient every day*. When the CAMC Health System identifies an essential physician need, an access issue for patients, or when the existing provider community cannot provide an essential service, IHCPI through its affiliation with CAMC Health System works to fill the gaps. Currently, IHCPI supports orthopedic medical staff for CAMC Teays Valley Hospital. Overall, IHCPI practices see a disproportionate share of the uninsured and underinsured in their practice locations.
